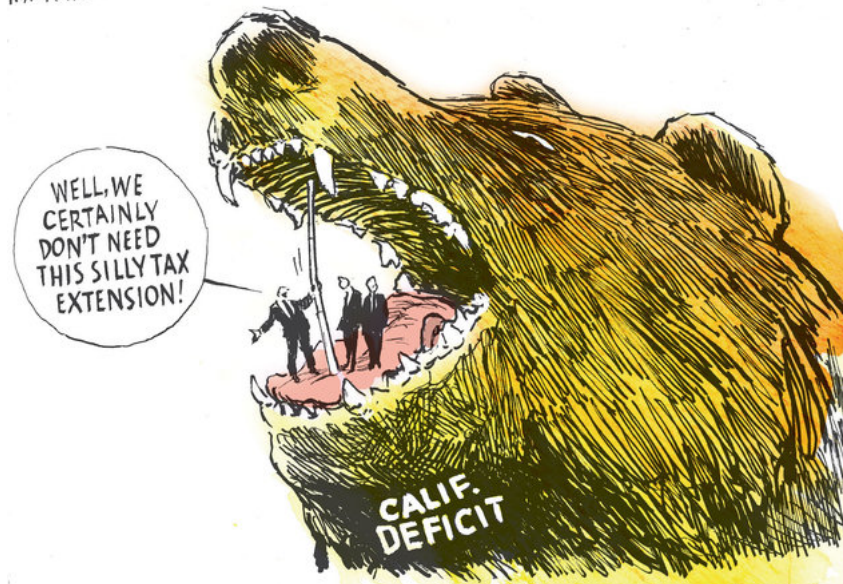

### **Governor Urges Business to Support His Revenue Plan**

Gov. Brown has met with business leaders in efforts to enlist their support for his budget proposal. He is also seeking support for his plan to put a measure that would extend the current temporary state taxes before voters this spring. Without that extension, the state could suffer another \$12.5 billion in cuts and additional reductions of more than \$2.3 billion in school funding.
